## **SHIRE UPDATE, MAY 2020**

### **COVID-19 Update**

Council is very aware that the community and local economy will be heavily impacted by the Covid19 pandemic. Council has introduced a number of measures that provide support to assist the financial recovery of the community. In response to the Covid-19 impacts, the Council has implemented the following measures:

Convened a Financial Recovery Working Group with membership comprising Councillors, staff, industry and business representation.

Resolved to freeze any rate increase for the 2020/21 financial year.

Waived charging penalty interest on overdue rates from 1 April 2020 to 30 June 2020.

Provided relief in the form of a reduction in lease payments due from tourism businesses leasing Shire property.

Visited more than 60 businesses to provide information and support.

Reduced sporting bodies fees so that they are only charged for the period 1 July 2019 to 29 February 2020 this financial year.

A Community Recovery Working Group has also been convened to provide support for community groups and individuals. This group is collaborating, delivering programs and services within the community, and providing online and practical support for residents, particularly for families and those that are isolated and/or vulnerable.

To assist those who are in home isolation or with social distancing, the Library is offering an expanded Books on Wheels program, a click and collect service and online Rhyme Time and Story Time. Roche Park Recreation Centre is offering an online Wellness Challenge and encouragement to maintain wellbeing.

The purpose of the law is to provide for the orderly management of activities and trading in the Shire's thoroughfares and public places.

## RIGHTS IN WATER AND IRRIGATION ACT 1914

Shire of Collie has made application for a permit under s11 to interfere with the bed and banks of the Collie River to replace the existing Venn Street Weir with a new structure at Crown Reserve 23560.

People who are interested in the application, may make a written submission within 15 days of this publication to the Department of Water and Environmental Regulation, PO Box 261 Western Australia, 6230, quoting DWERT968-2.

## RESTRICTED BURNING PERIOD

The entire Shire of Collie has now entered a restricted burning period. Meaning you now need to obtain a Permit to conduct any burning of Paddocks or stubble, bon fires or garden refuse until the 31st of May.

Permits are free and can be issued by your areas Fire Control Officer or through the Shire Rangers. Contact details can be found on the Shires website, on the back of the Hazard Reduction notice issued with your rates, or by phoning the Shire office on 9734 9000

Please note any burning done without a permit is an offence and infringements can be issued.

## HERITAGE FACADE UPGRADE

The Shire of Collie has recently completed the reconstruction of the historic verandah and balcony at the front of the Bilbe's building at 115 Throssell Street.

This project was part funded by the Shire's ongoing Facade Upgrade Incentive program in partnership with the previous and current owners of the building.
