- Premises will be deemed not to be adequately fenced if there is more than one escape of a dog from the premises
- Dogs to be walked on a leash in a public place unless in a dog exercise area
- The keeper will have during the term of the permit adequate space for the exercise of the dogs
- Property is kept clean of dog excrement
- The Shire receives no complaints from residents in the area, concerning a noise or wandering problem
- The permit holder will not substitute or replace any dog once that dog dies or is permanently removed from the premises
- Advise the Shire should you change your address or your dog/s dies.
